#### **FOR WHAT IT'S WORTH (FWIW)**

#### THE PROJECT

The purpose of "the project" is to tell people of the Good News of Jesus Christ. To accomplish this, the simplest of methods is used.

#### **HOW TO BRING SOMEONE TO CHRIST:**

Galatians 3:24 says the Law (Ten Commandments) is a schoolmaster that brings us to Christ. That is exactly what I want to accomplish, i.e. bring people to Christ.

#### "BELIEVERS, FREE FROM THE LAW"

One man, knowing my method of evangelism, brought me a book entitled "Believers, Free from the Law." I took it, thanked him and at home I went through it. The next time I saw him I asked, "Is it okay for you to blaspheme, worship idols, dishonor your parents, commit adultery, etc?"

He said, "No."

"So," I asked, "Are you free from the Moral Law?"

He said, "no."

"Do you have to obey the law of the land, speed limits, etc." He nodded his head yes.

"Then" I said, "you are not free from the Civil Law."

Romans 8:2 says that believers are "**free from the <u>law of sin and death,</u>**" not the Moral Law. This law is holy—and is intended to bring us to Christ. So, the method I use to bring someone to Christ is the Moral Law.

#### MATERIALS NEEDED TO BRING SOMEONE TO CHRIST:

The Moral Law, i.e. the Ten Commandments, evangelistic tracts and a small notepad (Since I am working on a project, I write everything down.)

When I go out witnessing, I don't usually carry a Bible with me. I do not intend to argue doctrine, (spiritual things are spiritually discerned) but to focus people on their need for Jesus Christ. I want to reason with people, not argue.

#### **REAL TV**

One time I was watching "Real TV" and there was a maniac on the streets with a two edged sword. He wielded it with expertise and people were absolutely terrified of him. The police came in, disarmed him and carried him off to the crazy house.

Big Bibles are not what make great witnesses. People with the Word of God hid in their hearts can, however, be very effective. Usually, when a big Bible is displayed, people are intimidated with that double-edged sword and they will do everything they can to disarm you with arguments. My desire is to present Christ, not argue.

#### **GOOD NEWS**

The good news, the death, burial and resurrection of Jesus Christ, is to them that perish foolishness. So, I hope to help them understand what makes the "good news" good news.

Problem is that most people think they are good. Solomon said, "Most men will proclaim each his own goodness, but who can find a faithful man?"

If people are good they don't need Jesus Christ. But the Ten Commandments show us God's standard is absolute holiness and perfection, or repentance. BTW, repentance is also a command!

When people declare their goodness I gently show them how they compare in light of God's Sovereign Standard. At this point they respond in one of two ways – either acknowledge their guilt, or justify themselves. If they justify themselves I do not share the Gospel (Jesus didn't either). The Law and the Holy Spirit must do more work in the lives of those who justify themselves. At this point my evangelistic effort is usually over even if the conversation continues.

If they acknowledge their guilt, I will show what Jesus did to redeem them from their condemnation. Even at that, I do not lead them in a "prayer of repentance" but show them that God expects them to leave their old life, giving them a totally new one.

#### Marina, St Petersburg, Russia

I met Marina while sitting on the benches at the Senaya Square in May 2006. She is an 18 year old university student. I asked her what she thought happened to the soul after death and she said she felt like good people went to heaven. I asked what happened to bad people and she said she wasn't sure.

Of course she told me she was a good person and I asked if she had ever heard of the Ten Commandments. She knew a few of them, but confirmed that she wasn't too good according to that standard. She then said that if God judged everyone according to that standard, everyone was going to hell. As I reasoned with her, you could see she was disturbed by the just demands of the law and the condemnation of her actions.

Only when she understood her guilt did I share the Gospel with her. At the end of our conversation I asked her if she knew how she could remove her condemnation. She said she would like to know, if indeed there was a way. I explained that God demanded repentance and faith in Jesus Christ. Then I asked her if she would like to pray and she said she would.

I said, before you pray there is something else you need to understand. I told her that Jesus gave everything, even His life's blood to redeem us from the curse of the law. If she prayed, she would give her life to Jesus and he would become the Master of her life and she would die to herself. At that moment her cell phone rang and she walked away. I sat for another ten minutes waiting for her to return, but she never did.
